Career Highlights

As **Chair of the Council on Social Work Education's (CSWE) Commission on Research** from 2015-2018, helped rewrite the group's mission statement and collaborated to build initiatives to embrace it, including establishing with SAGE Publications a national award for Innovation in Research Instruction, updating CSWE's Research Priorities, developing a comprehensive bibliography and 4 webinars on teaching research, and sponsoring of the first national Faculty Survey on Quality of Life.

As **Director of the PhD Program in Social Work at VCU for 13 years**, successfully established a "culture of completion" and played a role in the recruitment and graduation of over 100 doctoral students with an 85% retention rate and the formal involvement of 95% of the faculty in the program.

As elected **Chair of the Group for the Advancement of Doctoral Education in Social Work (GADE)**, the national professional organization of all social work PhD Directors, played lead role in updating the organization mission statement, commissioning the updating of the GADE Guidelines for Quality in Doctoral Education, and expanding GADE's visibility through the establishment of a reception at *Society for Social Work & Research* conference. Received their **2021 Educational Leadership in Doctoral Education Award**, presented at CSWE's Annual Program Meeting in Orlando, FL.

Directed **eleven PhD dissertations** and launched students to successful careers as scholars and leaders in the social work academy and in practice. Served on 18 other dissertation/thesis committees; **Formally mentored junior faculty** through the promotion and tenure process, which has been formally recognized by CSWE's Council on the Role and Status of Women as well as VCU's social work doctoral alumni.

With grant money awarded by the Ittleson Foundation, planned and implemented the **first ever National Conference on Social Work and Psychopharmacology** in 2003, which took place entirely on the World Wide Web with commissioned papers and competitively chosen books reviews uploaded then discussed in chat rooms by virtual participants around the world.

Appointed by Commissioner Dr. King Davis in 1991 to **chair the 45-member statewide advisory council for Virginia's Department of Mental Health, Mental Retardation and Substance Abuse Services** and played a role in getting legislation passed requiring consumer & family representation on its Board.

Taught ~ 150 course sections and supervised 61 independent studies; Developed from inception numerous MSW elective and required syllabi including "Social Work Practice in Community Mental Health," "Social Work Practice & Psychopharmacology," "Mental, Emotional & Behavioral Disorders," "Social Policy and the Mental Health System," and "Foundations of Research."

Published **3 books** (one in revision for 5th edition), **over 80 articles, book chapters, and book reviews**, made ~60 national and 150 local presentations, **winning author awards in 2016 for "Best Conceptual Article" and "Best Quantitative Article"** by the *Journal of Social Work Education*.

Served on editorial boards of important journals in the discipline including *Social Work*, *Journal of Social Work Education*, and as charter member of *Research on Social Work Practice* and *Best Practices in Mental Health*, winning "**Reviewer of the Year**" **twice by the Journal of Social Work Education**.

Served for **over 25 years as a CSWE Accreditation Site Team Member, Site Team Chair, and external program consultant** involving ~25 evaluative on-site visits to BSW and MSW programs around the country.

Served **six years on the Board of Directors of the Virginia chapter of the National Alliance on Mental Illness**; active in developing and disseminating a model of family education around the state.
